Definition

- “variety” means a plant grouping within a single **botanical taxon of the lowest known rank**, which grouping, irrespective of whether the conditions for the grant of a breeder’s right are fully met, can be
 - defined by the **expression of the characteristics** resulting from a given genotype or combination of genotypes,
 - **distinguished** from any other plant grouping by the expression of at least one of the said characteristics and
 - considered as **a unit** with regard to its suitability for being propagated unchanged






Application of Agricultural Varieties




2 years of testing

- VCU
- Value of Cultivation and use

- Optional: additional tests

2-3 years of testing

- DUS
- Distinctness, Uniformity and Stability
- CPVO protocols/UPOV guidelines
- Nearly all species (bilateral agreement)
- One location (Tystofte)



EU requirements regarding the VCU-examination



- EU-directive
 - Yield
 - Resistance to harmful organisms
 - Behaviour with respect to factors in the physical environment
 - Quality characteristics
- National freedom regarding the exact testing protocols and financing and testing





The value of a variety for cultivation and use shall be regarded as satisfactory if, **compared to other varieties accepted in the list of the member states in question**, its qualities, taken as a whole, **offer at least as far as production in any given region is concerned a clear improvement** either for **cultivation** or as regards the uses which can be of the crops or the products derived there from. Where other, **superior characteristics** are present, **individual inferior characteristics** may be disregarded.





DK-VCU-testing of spring barley

- 5 yield trials – direct comparison with all varieties on the Danish market and new applications –
 - 2011: 82 varieties + 1 mixture reference
 - fast results
- ID-test between 2nd year and DUS sample
- Disease assessments in obs-plots 25 locations publication – updates during the growing season
- Nematode resistance
- Growing characteristics (length lodging maturity etc)
- Quality assessments
 - Protein, starch, grading, hkl-weight
 - Optional: e.g. malting feeding quality – digestibility, Amino acid distribution
- Optional eg: organic yield testing
 - 2011: 26731: SJ107844 2.år 2011
 - 27412: SJ111998 1.år 2011


DK-National Listing (DUS & administration) of spring barley

Costs 2011 – requirement of full cost recovery

Application	4.500 kr

Contribution and project will be developed in cooperation with the relevant stake holders eg plant breeders – organic growers etc

First possibility to apply will be in 2012


