On November 4, 2008 Minnesota voters approved the Clean Water Land and Legacy Amendment to the state constitution

The Amendment increases the sales and use tax rate by 3/8th of 1% on taxable sales, starting July 1, 2009 and continuing through 2034.

Dollars are dedicated to four funds:



Step 3. Develop strategies to restore and protect the watershed's water bodies

- •Summarize details on water quality issues.
- Determine reduction goals for impaired or protected water bodies.

Outcomes:

- •Total Maximum Daily Load (TMDL)
- •WRAPS Report

Step 2. Assess the data

- •Identify impaired waters (do not meet standards).
- •Identify stressors affecting aquatic life.
- •Analyze data with water quality models and maps.


