3. Report from Brussels, Riga and further to Horizon 2020

Meeting in Brussels

Irene reported from the Annual Meeting for EIP water. It seems a good idea to join some of the Action Groups. We should inform each other if we are in contact with relevant Action Groups, which might be relevant for some of the WaterCAP TaskForce partners.

Meeting in Riga – a good meeting

Enno is the driver in the process. He will send a proposal early January 2014, including a possible application for an AG on groundwater and upcoming projects in relation to Horizon 2020.

Drenthe are in good contact with the national contact point in Horizon 2020 – other partners should consider getting to know their national contact point.

Other activities in relation to Horizon 2020

Rivers Trust is working on getting rivers basin networks included as part of Horizon 2020.

4. Aberdeen

Can we use RT's stream simulator for "poster session" at the annual meeting – a way to discuss the catchment process? Rolf will contact the secretariat in order to secure that we are being considered at the event, and then we will consider if the Stream Simulator could be a part of our performance.

What material to bring?

We will work on a brochure, including the historical background (our partnerships) and how it can support the challenges in the North Sea Region for the next 7 years? Include ideas for new projects. Ben makes a proposal – suggestion will be sent out before telephone/Skype meeting in January.

We will consider having a Steering Group meeting perhaps a day in advance of the annual meeting.





5. Final meeting in UK

At this meeting we will look at the future water challenges for the NSR, including discussion of the applications – the 7 challenges (from the MTTF) - which we are working on.

We will invite a relatively small group – innovative (50 - 100 people). We will invite other relevant partners. Invitation also to Lise Johnsen from the secretariat. The meeting will take place on 11 - 12 November 2014 + 1 extra day for the Steering Group. Alistair will write a proposal/suggestion for an agenda. Responsible for the event: Alistair.

6. Spread the word about MTTF

Try to spread the word about the MTTF.

We discussed how to involve countries other than the partner countries? How do we communicate the knowledge to non-partner countries?

It was decided to invite other contacts to the Aberdeen Annual Meeting in June. Further, we will all focus on spreading the WaterCap TaskForce knowledge to other organisations in the EU via our different networks.
