1. Evaluation of the first two MTTF and the conditions of the rest

The meeting about Nitrate in April in Oldenburg – it was a really good bilateral meeting. The attendants learned a lot about possibilities on how to use N-min. Hans will fill out a template with the main learning's from the meeting. He will send it to Silke and she will make sure it's circulated to the relevant people from Oldenburg (Deadline 8th of May 2014)

Return visit is planned to take in the second half of the year – then Egon Harn, Johannes grosser by large can attend (Silke and Hans are responsible for the visit). Silke will contact Hans

The meeting in UK - The governance meeting - we have just finalized the first meeting

Next meeting will take place in September in Denmark. We expect it will include other MTTF issues (Barry will ask local River Trusts what they would like to get to know more about – it could be ground water protection, how Denmark make wetland restorations, how Denmark work with nature protection in designated areas like in the Natura 2000 areas, how Denmark are mapping nature, ground water protection areas, areas where farming should have high priority, etc. (we are having many GIS layers. Many but not all are open for all...) and perhaps how Denmark educate young farmers

The meeting in the Netherlands – the Sea barrier MTTF – CDR has invited 7 municipalities (21 people to attend) they are going to the Netherlands and Germany. Rolf is doing the planing

The sustainable drainage MTTF: need to find a date possible in the first 2 weeks of July – Barry is doing the planning

The Netherlands - Efficient irrigation 16 - 17 June – Rinke has made a nice proposal. KCA are working on the suggestion and expect 5 - 7 people to attend the meeting. Irene will make sure we answer Rinke next week with suggestions for adjustments to the program etc. Oldenburg might be interested I attending the meeting.


The communication plan should be finalized /Ben will make sure that we get the final version within 3 weeks


