WP2 Multi-actor implementation 2.1

Status

A status in all the case areas 13. May at a WP2 MS Team meeting showed that situation in all countries has a challenge with covid-19 and meetings in the project. Despite the situation, everyone in the case areas continues the work in Waterdrive. The focus group meetings are impossible to implement in the form they have been envisaged. The meetings are at the moment done by individual meeting or in small groups in the fields. Small cross sector meetings in fields and the landscape are obvious in Waterdrive. If the situation continue in autumn, it can be necessary to train the farmers in MS Team, Zoom, Skype ect. The travel costs can then maybe be used to do videos and training to fulfill the work in Waterdrive in each country. Videos are best from May-September in the landscape, so here we have to decide soon which road we choose. The PCT team are working with the challenge.

Newsletter about the progress in case areas in august September done by the case area leaders. Zanda and Frank will work with a template/a first draft. It will make sense to combine it with the policy recommendations in WP4.

Implementation- and investment plans

The next important steps in Waterdrive is to make local implementation- and investment plans. Each case area leader make a report about implementation- and investment plans in the Waterdrive case area. Here it is important to show the environmental measures, the landowners and the levels of cross-sector cooperation. Reflections and conclusions in the end of the report shall feed into the communication of Waterdrive. What are the challenges and how shall they be solved? The calculations in the investment plans has to be in Euro. Anne Sloth, catchment officer in Denmark are working with the task in May and you will all get a copy. Each country has to find their own way to report implementation- and investment plans because we are working with very different tasks.


Participartory toolbox
